The above amendment was reviewed at the meeting of the Sub-Committee of the North West REC held on 30 January 2007.

Ethical opinion

The members of the Committee present decided that it could not give a favourable ethical opinion of the amendment, for the following reasons:

The amendment sought approval for the British Society for Rheumatology Biologics Register (BSRBR) to collect drug adherence data on patients with rheumatoid arthritis (RA), via a "Views on Illness, Treatment and General Health" questionnaire. In addition a page on drug adherence had been added to the 6 month follow-up questionnaire.

Drug adherence remained a problem in this disease group and the role of psychosocial factors in predicting adherence, and the role of adherence in predicting treatment response, warranted investigation.

A comprehensive, clear and well written rationale had been submitted in support of the amendment.

The Sub-Committee whilst in agreement that the proposed amendment was a worthwhile addition to the BSRBR and may potentially yield valuable information on drug adherence, sought clarification and further action on the following:

- It was recognised that the "Views on Illness, Treatment and General Health"
 questionnaire was an amalgamation of excerpts from a number validated
 questionnaires. However, further clarification was sought as to whether the
 questionnaire had been validated in its current amalgamated format, or whether it had
 been piloted and was suitable for the intended purpose.
- 2. Following on from the above. The approved patient information sheet should be amended to reflect the introduction of questionnaires which are intended to collect quality of life data. The possibility that patients may be asked questions of a sensitive nature should highlighted. An amended Patient Information Sheet should be submitted for review.

I regret to inform you that the amendment is therefore not approved. The study should continue in accordance with the documentation previously approved by the Committee.

Modifying the amendment

You may modify or adapt the amendment, taking into account the Committee's concerns. Modified amendments should be submitted on the standard notice of amendment form. The form should indicate that it is a modification of the above amendment.

A revised notice of amendment must be submitted at least 14 days before you plan to implement the amendment. The Committee will then have 14 days from the date of receiving the notice in which to notify you that the amendment is rejected, otherwise the amendment may be implemented.
